Round Table discussion: Tom Hoffman the NEDiv executive steward would like the home regions of the divisional administrators to sponsor their attendance at the event. Motion made by Sandy Sanders, second by Tim Meddaugh to support up to \$250 for NEDiv divisional administrators. Motion passed. There was discussion of how much financial support we give to Glen Region members who are working during the RoundTable; ie registrars, photographers, seminar recorders, etc. Everyone will pay for dinner @ \$30.
