CALL TO ORDER: 7:05 pm

MOTION: Phil, Kyle: Approve March minutes as presented. CARRIED.

PO BOX: Allan working to change ownership on Watkins Glen PO Box and acquire new keys.

TREASURER: \$9500 in checking account and \$136k in investments. Have paid remainder of Sprints payment.

MEMBERSHIP: Currently 264... had 8 each expired and new members. Pauline had noted a couple of the expired members had shown interest in Solo so we expect they may renew when the season starts.

ACTIVITIES: Nothing currently planned.

WEBSITE: Pat working on fix for email issues discovered earlier this year. Has a temporary page set up with some Glen Region domain email addresses forwarding. Still working on the previous form.

GREEN GRAND PRIX: Had a very successful event. Bob has received all positive feedback. Ed completed a few sessions of tech inspection on his race car, along with a Formula Vee. Received good feedback from new WGI president. Unfortunately may be missing a couple loaner helmets from the autocross event. Bob has sent emails out to known attendees - waiting to hear back. May consider having a sign out option by school or some other means. Bob working on transition of leadership for the event. Hoping to have Jason Kellogg attend next month's Glen Region board meeting to familiarize with region personnel. Did have some confusion around app for rally timing. May look ahead to limiting size of rally and autocross in future. This year felt like it may have maxed out. Would potentially give priority to schools and limit additional entries.

CLUB RACING: Supps are done and registration is open. May end up with some overtime based on schedule. Also seeing potentially new charges from catering (setup charge and service charge). Will be the same menu both days but more expensive than last year.

SOLO: Have confirmed Chemung Speedrome as an additional site for 2024. Will share with Southern NY also. Rental fee will be \$100. Will be sharing their event schedule at our events/website. SNYR is negotiating with Shangri-La Speedway for additional options. Currently have an 8 event tentative schedule. Hoping to finalize and confirm soon. Have a Solo planning meeting scheduled for tomorrow.

WGI CONTRACT TICKETS: Appears that WGI has significantly reduced ticket allocations for 2024 events. Still 50 NASCAR tickets split between general admission and grandstand and only 10 IMSA tickets. There will be no JD Club or other pit walk/etc events.
