CALL TO ORDER: 7:00 pm

MOTION: Phil, Kyle: Approve May minutes as presented. CARRIED.

CORRESPONDENCE: Have received a Thank You message from Jeff Jacobs for the SCCA Foundation (for the Ed Jakobus media project).

MEMBERSHIP: Same as last month - 267 members. Have 5 new/renewal and 5 expired.

TREASURER: Currently \$8k in checking. \$137k in investments. Currently pulling together detail for taxes.

SOLO: Event this past Sunday at CCC. Had 30 drivers registered - one of the best in the past couple years. Course was well-received and quick, despite working around lot conditions. Have made out OK on money so far. Went ahead with purchasing a new laptop. Already in hand and set up/ready for the next event. Allan to test with equipment before event to confirm everything is ready to go. Still looking to get 2nd scoreboard - hopefully wireless. Farmtek has a wireless 8" that would be ~\$1300 all-in for an 8" with case, wireless interface, and battery. Next event is Chemung Speedrome on July 13. Southern has already run an event there (though with an incident), will need to confirm course as planned is still OK.

CLUB RACING: Currently at about 125 entries. Break-even may be near 170-180. Have 13 FV Challenge at the moment. Were promised 20 and expecting more. Also have USTCC and MARRS attending. Expecting to continue to see entries for the next week and a half. Otherwise everything else is on track. Super Tour was run by FLR this year. Event seemed to run well enough but entries were a bit lower than expected (had an unusual date thanks to WGI's schedule changes throughout the year).

MEDDAUGH ESTATE: Have had contact from Tim's sister/estate attorney with a draft "receipt and release" document. Not ready to sign but currently in review.
