Solo Rule Changes

The days of R compound tires ruling Stock classes are coming to an end. Starting in 2014, Street is the new Stock and a few more changes are on the way for 2015.

The biggest change for 2014 is of course the lack of race rubber and the new Street class structure - and there is also now a minimum tread wear rating for Street classes. For 2014 that minimum rating is 140 - then increasing further in 2015 to a minimum of 200.

Another interesting change is allowing a +/- 1 inch change in wheel diameter. Wheel width must stay the same, but diameter now has more flexibility with the intention of allowing greater tire selection for many cars. Drivers will also now be able to disable traction/stability control by removing a fuse or disconnecting a sensor.

With all these (and a few more) changes and the new Street classes, Stock as we know it is actually not going completely away... yet. For 2014 there will be Stock-R (SR) classes based on the 2013 rule set and allowing R Compound tires. For 2015, those Stock-R classes do go away and leave simply an SSR class for the current Super Stock eligible cars.

You can read more about these and other changes in recent issues of Fastrack News and keep an eye on the Solo Rules site for the 2014 rule book to of Directors, right? And this BoD, they do stuff? Good. But do you know what stuff they do or what offices our board is comprised of? No? Well how about we tell you a little about the Board and what they do...

Our current Board of Directors is made up of 10 different people. Those positions currently include our Regional Executive (or just, RE), the Assistant RE (kind of like a VP), the Secretary, Treasurer, Activities Director and four other Directors - as well as a past RE serving as a "Senior Advisor."

With the exception of the Directors (two year terms) all of the elected officials have a 1 year term. Directors also have a term limit of no more than two consecutive terms. After the term limit is reached. Directors could choose to run for another position or leave the board with the option of running for Director again in the next election if they choose.

Hopefully many of you were already aware of how our Board operates (many of you have likely served on it!). For those of you unfamiliar, in future issues we will try to highlight each of the Officer positions so that you have a better understanding of the club's operations. Maybe you'll find something interesting enough to get more involved!
