CALL TO ORDER: 7:00pm

MOTION: Kyle, Cheryl: Approve January minutes as presented. CARRIED.

TREASURER: \$31k in checking - both deposit checks to WGI have cleared. Investments down to \$101k - after transferring \$25k to checking to cover track deposits.

MEMBERSHIP: Currently at 256 (just down 1 from last month).

ACTIVITIES: Thanks to those that came to the awards banquet. Expected about 30 attendees but ended near 40!

GREEN GRAND PRIX: Expecting hybrid bus and also possibly fully electric bus. Potentially NASCAR EV cup car may show up (oval track car). May be able to do small demo in front of media center but not on track. Still planning live stream to those that cannot attend. Williams Toyota to donate prize money for autocross. Bob finalizing sanction requests - looking to confirm officials for autocross. Looking for clarity on what volunteers are needed for non-autocross. May be able to recruit some members to help. Bob to send roles needed to a number of people.

CLUB RACING: Received notice from Daytona office that the region was owed money. Appears to be payment for 2022 July Sprints catering. Not sure of specifics or why, but a check is supposed to be in the mail. Expecting that the money is still owed to catering - but not sure how we would know or even who to ask, given that it would have been paid to where requested. Also finalizing LOA to get back to National. Ray Carmody has ordered some supplies for the Vee series but wanted to confirm if we see a bill or a check from him to cover those charges. Have a number of officials for July Sprints already, thanks to Chuck. Possibly coming down to 6 groups instead of 7. Working on budget and hoping for about 125 cars, expecting to price around \$550 with discounts for multiple entries. Currently debating lunch options. Have interest in A Sedan for another group option to double dip. Did look into Time Trials option for the Sprints weekend but couldn't get the timing to work out.

SOLO: Trying to get update from WGI on status of lots available. Hoping to use the North Paddock again after no being allowed last year. CCC has confirmed availability of both lots we've previously used (but both still in same condition - which is questionable). Still planning to use Arnot Mall. Waiting to hear from Corning on Big Flats plant. Have a tentative schedule. Working to coordinate with other regions in area to keep the schedule as open as possible. Still looking at software/display upgrades. Also option of add-on module to make display wireless.

NEDIV MINICON: Held on 2/11 - was well attended. Good variety of seminars and attendance from national office.
